### (D) WARHAWK PARK PROJECT UPDATE

Executive Assistant Reeves had a sight visit with Kondwani Patterson -Each One Teach One Foundation and the Thompson Charitable Foundation to get a plan together for multiple components of this project. They asked that the Thompson Charitable Foundation release the grant funding that they had given to Each One Teach One. We are to match in-kind \$37,980. With these funds we should be able to build a shelter with a bathroom, install a basketball/pickle-ball, possible playground, as well as install a walking path. Clinch Valley Community Action has received a playground grant for \$76,000. This grant must be expended by the end of the year. Once the Thompson Charitable Foundation releases the grant funding this project will be underway. Mayor Hoops is glad to see that this project is moving forward.

## (E) TAZEWELL CINEMAS & ENTERTAINMENT, LLC. IRF AGREEMENT (VOTE)
